The nature or purpose of the business entity:

The purpose of this business entity is to engage in any lawful act or activity for which the entity may be organized under the laws of Kansas.

A. This Corporation is organized NOT FOR PROFIT and the objects and purposes to be transacted and carried on are:1. To provide amateur athletic competition for police and firefighters.2. To encourage athletic spirit of competition in communities.3. To educate the community on the benefits of a fit and healthy lifestyle;4. The corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code; and5. Subject to the purposes stated above and not contrary thereto, the Corporation shall have and may exercise all the powers conferred by the laws of the State of Kansas upon non-profit corporations formed under the laws pursuant to an under which this Corporation is formed, as such laws are now in effect or may at any time hereafter be amended.B. Specifically, this Corporation shall have the power to acquire, purchase, hold, lease, convey, mortgage and pledge such real and personal property in Kansas, other states of the United States, or elsewhere as shall be necessary or convenient to the transaction of its business and the realization of its objects and purposes. PROVIDED HOWEVER, that in all of events and under all circumstances, and notwithstanding merger, consolidation, reorganization, dissolution, or winding up of this corporation, voluntary or involuntary, or by operation of law, the following provisions shall apply:1. This Corporation shall not have or exercise any power or authority either expressly, by interpretation, or by the operation of law, nor shall it directly or indirectly engage in any activity, that would prevent this Corporation from qualifying, and continuing to qualify, as an organization described in Section 501(c)(3) of the Internal Revenue Code;2. This Corporation shall never be operated for the primary purpose of carrying on a trade or business for profit.3. No compensation or payment shall ever be made to any officer, director, trustee, creator or organizer of this Corporation, or substantial contributor to it, except as an allowance for actual expenditures or services actually made or rendered to the Corporation; and neither the whole nor any portion of the assets or net earnings, current or accumulated, of this corporation shall ever be distributed to or divided among any such persons unless otherwise provided in the Bylaws. Provided further that neither the whole nor any part or portion of such assets or net earning shall ever be used for, accrued to, or inure to the benefit of any member or private individual within the meaning of 501(c)(3) of the Internal Revenue Code of 1986m as may be superceded or amended.

This corporation will not have the authority to issue stock. The conditions of the membership are set in the bylaws.
